Address water problems in Patparganj: Bharadwaj

New Delhi: Water minister Saurabh Bharadwaj along with DJB officials on Friday visited Patparganj area to understand the issues faced the locals regarding contaminated water.

An on-site inspection of the 2.4MGD (million gallons per day) capacity underground reservoir (UGR) located in Patpargani was conducted by DJB officials.

Bhardwaj instructed the officials to promptly address the issues related to the supply of drinking water in respective areas. He also directed DJB officials to identify the reasons for declining water levels and restore the water flow.

Bharadwaj stated that the causes of decreasing water levels will be identified and the water flow will be restored.

"The issue of leaks will be promptly resolved to eliminate water crisis. This will ensure that the residents of the affected areas do not face water scarcity. Along with the improvement in water pressure, the water quality will also be enhanced" said Bharadwaj.

According to officials, the UGR in Patparganj was constructed to alleviate the water crisis for the residents of Patpargani and nearby areas dutap Vihar, Patparganj Gaon, Mayur Vihar Phase-1. TNN

Another Paradiso tower tagged unsafe, may be vacated soon

Gurgaon: The district administration has declared tower G of Chintels Paradiso in Sector 109 unsafe for habitation due to severe structural deterioration, over three months after it stated that towers E and F of the residential society are unfit for living.

Another building, tower A, is liveable as of now but deterioration has been noticed in it as well and a structural audit is recommended annually to ensure safety of residents. The defects were revealed in the structural audit report of towers A and G by IIT-Delhi, which was released by the district administration on Friday.

The report also said high amounts of chloride have been found in the concrete used in tower G, due to which steel bars have been corroded, making the building unsafe. The tower has a total of 56 flats and 34 families are living there at present. Tower A has 64 flats, of which 60 are occupied.

"We have declared tower G unsafe for habitation as the IIT-Delhi audit report states it is in danger, while tower A is of vacating tower G will begin the project.

soon. The audit reports of the remaining towers are also being sought at the earliest," additional deputy commissioner Hitesh Meena said.

A spokesperson for Chintels India, the developer, said: "We have not yet received the official report of these two towers from the district administration. We will wait for the report of the Central Building Research Institute (CBRI), which is conducting its own structural audit, before jumping to any conclusions".

IIT-Delhi had already declared towers E and F unsafe for habitation in its report submitted on February 14 this year. The process of compensation settlement for flat owners of towers D, E and F is going on under the supervision deputy commissioner Nishant Yadav. Chintels has given what it said is the "final offer" to residents of these three towers to opt for compensation or get their flats repaired or rebuilt.

As of now, around 12 families are yet to vacate their flats in towers E and F despite repeated orders to do so by the district administration.

Height Barrier On Barapullah **Corridor Broken Within Days**

New Delhi: Within a few days of the installation of a height barrier at the entrance of Barapullah elevated road from Sarai Kale Khan on Ring Road, a bus has broken it.

"A bus destroyed the barrier, we will reinstall it," said an official of the National Capital Region Transport Corporation(NCRTC)that installed the barriers this week.

Heavy vehicles are not allowed on the Barapullah flyover and installing the height barrier was a step in enforcing the rule more strictly. The first barrier was installed at the entrance from the Ring Road to the Barapullah flyover.

It was done as a safety measure in coordination with

undabout. According to officials, the other points of entry to the flyover will also have this feature. The height barrier allows vehicles up to the height of 3.5 metres to pass.

The PWD had earlier installed height barriers on the newly constructed Ashram flyover extension stretch because of a high-tension line passing over a section of the elevated road, but those were also broken down within a few days.

Earlier, Delhi Traffic Police officials had written to the PWD, saying movement of heavy vehicles was causing traffic congestion on the stretch. There are two entry points near Sarai Kale Khan to the Barapullah flyover which are generally congested because they are close to the inter-state bus terminal and rapid rail station construction.

Constructed in two phases, the elevated corridor provides a signal-free link between Ring Road and Aurobindo Marg.


